# TAG HR Temporary Help Services (THS)



#### What is the THS supply arrangement?

The temporary help services supply arrangement (SA) is the mandatory method of supply designed to assist federal departments in the National Capital Region (NCR) with their procurement of temporary help for an assignment period that does not exceed 48 consecutive weeks.

#### There are only 3 situations in which THS can be used:

- when a public servant is absent for a temporary period of time
- when there is a requirement for additional staff during a temporary workload increase, in which there is an insufficient number of public servants available to meet the requirement
- a position is vacant and staffing action is being completed

#### How to get started

- Confirm your budget allocation
- Define the role
- Select the appropriate stream and category
- Contact your procurement authority for the appropriate intake forms
- Fill out the procurement intake forms and develop a statement of work
- Submit the full requisition
- Reserve time to evaluate the proposal
- Schedule a kickoff meeting

# Staffing Arrangements

A transfer fee will be payable to the contractor by the identified user when the "office" where the THS resource has been assigned during the contract period hires the resource without competition, either on a casual, term or indeterminate basis, prior to the passage of up to 20 calendar weeks measured from the start of services under the contract regardless of a change of duties.

- Greater than 18 and up to 20 weeks from the start of services: 2%
- Greater than 16 and up to 18 weeks from the start of services: 4%
- ▶ Greater than 14 and up to 16 weeks from the start of services: 6%
- Greater than 12 and up to 14 weeks from the start of services: 8%
- Greater than 10 and up to 12 weeks from the start of services: 10%
- Greater than 8 and up to 10 weeks from the start of services: 12%
- Greater than 6 and up to 8 weeks from the start of services: 14%
- Greater than 4 and up to 6 weeks from the start of services: 16%
- Greater than 2 and up to 4 weeks from the start of services: 18%
- Greater than 0 and up to 2 weeks from the start of services: 20%
